# Gamekeeper survey 2020

Run in partnership with the Countryside Alliance (CA), Game Farmers Association (GFA) and the National Gamekeeper's Organisation (NGO).









**Date:** 16<sup>Th</sup> Dec 2020

#### Introduction

A short survey was requested to try and ascertain the level and type of abuse gamekeepers have directed to them by members of the public, and to establish what wildlife crime/unlawful activity is carried out by the public on shooting land.

The survey weblink was sent to a sample of 2,372 BASC gamekeeper members (who are willing to receive surveys) via fast track and was also distributed by The National Gamekeepers Organisation, The Countryside Alliance and The Game Farmers Association. Each organisation was provided with an individual weblink to enable us to ascertain which organisation the respondents came from. The survey was completely anonymous.

The survey was distributed by BASC at 9am on  $30^{th}$  November 2020 and closed at 12 noon on  $14^{th}$  December 2020. A reminder was sent by BASC on Friday  $11^{th}$  December 2020. At the time of closing there were a total of 1,048 responses (BASC = 658 / NGO = 372 / GFA = 12 / CA = 6).



#### **Key results**

## Q1. As a gamekeeper have you ever experienced abuse / threats from people outside your profession because of your occupation?

Total respondents:

• Responses: **YES** = **64**% (n=667) (*Directed to Q2*) **No**= **36**% (n=381) (*Directed to Q5*)

## **Q2.** Please indicate the types of abuse/threat you have experienced – Respondents were asked to tick all that apply.

- *Verbal* = **61%** (n=642)
- *Physical* = **15%** (*n*=154)
- Online (social media) = **18%** (n=192)
- Letters = 3% (n=36)
- Other = 3% (n=30)

Those respondents who selected 'other' were asked to expand on their answer. Their responses (n=29) have been categorized for ease of analysis and can be seen in table 3.

# Q3. How many incidents of abuse/threats have you experienced during the last 12 months as a gamekeeper?

Table 4 shows respondents suffered the majority of incidents between 1-10 times in the last 12 months.



## Q4. Has the number of incidents you have experiences increased or decreased compared to previous years?

Most respondents indicated the number of verbal and physical incidents stayed the same as previous years. However, many respondents explained the number of online incidents had increased in the last 12 months.



# Q5. As a gamekeeper have you ever witnessed an act of wildlife crime by a member of the public on the ground you work on?

• Responses: **YES** = **59**% (n=584) (*Directed to Q6*) **No= 41**% (n=405) (*Directed to Q7*)

### **Q6.** Please indicate the type(s) of wildlife crime you have witnessed – Respondents were asked to tick all that apply.

Respondents were provided with a list of different forms of wildlife crime and asked to choose all they have been witness to. All 'other' responses were categorised for ease of analysis and can be seen in Table 7.

# Q7. As a gamekeeper have you ever witnessed any unlawful activity by a member of the public targeted at shoot related activities?

• Answer: **YES** = **61%** (**n**=**595**) (*Directed to Q8*) **No**= **39%** (**n**=**379**) (*Directed to Q9*)

## Q8. Please indicate the types of unlawful activity you have witnessed – Respondents were asked to tick all that apply.

Respondents were provided with a list of different forms of unlawful activity and asked to choose all they have been witness to (see table 9). All the 'other' responses were categorised for ease of analysis and can be seen in Table 10.
