The advantages of affiliation

BASC represents and cares for the interests of members of affiliated clubs and syndicates.

Continuing your BASC affiliation brings great advantages to both your club or syndicate and individual members. The exclusive membership package that we have developed offers exceptional value for money.

All members receive a package of services and benefits that includes:

- insurance to protect them wherever they go shooting;
- six issues a year of our members' magazine, Shooting and Conservation; and
- access to GoShooting a service for clubs and syndicates that offers free advertising to help them attract new members.



Insurance protection

As a 'first resort' insurance policy, the BASC policy takes on a claim regardless of any other insurance you may have. Cheaper options offered by others will not typically respond until you can prove no other policy will cover the claim.

- Up to £10 million third-party liability cover.
- Up to £10 million employers' liability cover.
- Up to £10 million product liability cover.
- Up to £50,000 personal accident cover.
- Only affiliated clubs and syndicate members have the additional 'guest insurance', providing that the guests do not exceed 50 per cent of the party.
- Only affiliated clubs and syndicates can take advantage of the additional public liability related to fundraising or education and awareness raising events. For example, if you wanted to put on a clay shoot and raise awareness and funds, as long as you notify BASC that the club and syndicate is undertaking the event then this element of the insurance will cover you.
- Only affiliated clubs and syndicate members have access to the additional dog injury protection. If a working dog is injured as a result of your club's or syndicate's negligence, then the cover will respond up to a cost of £2,500 per incident.
- By having club and syndicate insurance you always know that everyone in the club
 or syndicate is insured. If an incident occurs and you cannot identify exactly who
 caused it, then the insurance will still respond as everyone is covered. For example,
 you are unsure which Gun shot the bird that landed on a vehicle or property and
 caused damage.

BASC insurance for dogs has two parts

- Liability cover this covers you for an accident or injury your dog causes while picking up or working during a BASC recognised activity, e.g. driven shooting, wildfowling etc.
- Limited cover for injury to dogs they are only covered if the injury is due to the negligent actions of members of a BASC-affiliated shoot; cover is limited to £2,500 per incident.

Therefore, the injury/illness to the dog needs to have been caused by negligence and the person/club causing the negligence needs to be a BASC member for the BASC insurance to provide cover.

Unbeatable legal, practical and technical advice

BASC's firearms team is staffed by seven full-time employees. It includes four expolice personnel (including a firearms licensing manager) and a former gunsmith. It is headed by Bill Harriman, one of the UK's leading forensic ballistics experts and a published authority on the application of firearms law. The costs of firearms licensing and the efficiency of the licensing process are key areas of focus for this team.

Club rules

BASC requires all affiliated clubs and syndicates to have a set of robust rules to protect the members and officers, and assist in the smooth running of the shoot. These rules should cover:

- · the objectives of the shoot;
- · how you become a member;
- how you leave membership through resignation, failure to pay the subscription, etc.;
- rules of what members are expected to do and not to do;
- how disciplinary issues are dealt with and members' rights of appeal;
- · how officers are elected;
- · the roles and responsibilities of the officers;
- · rules around AGMs; and
- how money is handled and distributed.

All shoots are different, and the rules in place should meet individual needs and circumstances. BASC has produced a set of draft rules that can be edited to suit your shoot. You can download them as a Word document: basc.org.uk/join-basc/clubs-and-syndicates

Pro-rata payments

Subscriptions payable by members joining a BASC-affiliated club or syndicate partway through the club's subscription year are calculated on a monthly basis.

Below is a summary of our subscription rates and the pro-rata cost applicable to new members joining a club mid-year and before the annual club subscription is due. The pro-rata subscription to be applied will depend on the date BASC receives notification of the applicant's wish to join your club/syndicate.
